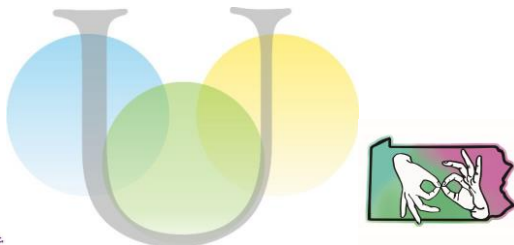

The workshop has 4 parts:

"The Process: Are They Really Letting Me Do This Unsupervised"- the A to Z of the medical interpreting process in the Dr's office and in the hospital. Preparation, professionalism, interpreting strategies, hospital protocol, giving report, HIPAA, informed consent, patient care standards, being a part of the medical team as the language expert, common medical abbreviations. (.4 CEUs)

"The Science: Danger, Don't Get Any On Ya" - an in-depth explanation of contact, droplet, airborne precautions, vaccinations, infectious diseases, operating room and the sterile field. Where to stand in the OR, How to safety work in medical settings without getting sick or infected, how to wear the appropriate PPE for each patient encounter and common cardiac meds. (.4 CEUs)

"The Mechanics: Can I Buy A Vowel" medical terminology (Latin prefixes, suffices and root words), techniques for interpreting medical questions and common medical tests (X-ray, MRI, Cat Scan, colonoscopy, endoscopy, heart cath). (.4 CEUs)

"The Switcharoo: Things Just Got Complicated". – what to do when medical assignments become legal, when medical assignments become mental health, involve palliative/hospice care, involved DFCS, sticky family dynamics, working with a 2nd language interpreter and common lab tests (CBC, Chem panel, BPN, etc.). (.4 CEUs)
